# Bluffton Breeze to Launch New Okatie Transit Route Pilot Route Starts Monday, October 2; All Passengers Ride Free Through March 31

**Bluffton, SC – September 25, 2023** – The Lowcountry Regional Transportation Authority (LRTA), operators of Palmetto Breeze Transit, the Breeze Trolley, and the Bluffton Breeze, are testing a new Bluffton Breeze route offering a new transportation option for residents and businesses in the Okatie, Sun City, and New River Crossing areas west of Bluffton. With the launch of the new route, which will connect its passengers to the existing Bluffton Breeze route, all rides will be fare-free for six months (through March 31, 2024). The Bluffton Breeze operates hourly service Monday through Friday, between the hours of 8 a.m. and 5:30 p.m., with stops across the Town of Bluffton and the surrounding areas.

"We have received requests for several years to expand our service west of Bluffton to offer new mobility alternatives to residents in the Okatie and Sun City areas," said Mary Lou Franzoni, Executive Director of the LRTA. "The route we are testing with this pilot project is designed to make it easier and safer for residents and visitors to go shopping, get to medical appointments, visit the weekly farmers markets in Bluffton, and to experience all that the Bluffton area has to offer," she added.

If the test of the new Okatie route is deemed a success by the passengers it serves, and the LRTA and its Board of Directors, LRTA staff plan to implement it as a permanent route in April 2024.

The Bluffton Breeze features more than 60 published bus stops, including bus stop signage to assist passengers in locating their nearest pick-up locations, as well as wheelchair lift-equipped buses, air-conditioning, comfortable seating, and two mobile apps ("CatchTheBreeze" to track the buses, and "BreezePass" to pre-pay fares when they are re-implemented). The service is complemented by the LRTA's "Easy Breeze" ADA paratransit services for eligible passengers who travel within ¾ of a mile of the published routes and who are not able to ride the fixed-route service.

Key destinations along the new route include: the Okatie Food Lion and Okatie Village, Legacy Medical Center, Publix at New River Crossing, the Walmart Supercenter in Hardeeville, Berkeley

Place, Lowcountry Fresh Market & Café at Washington Square, Vineyard Assisted Living & Memory Care, Buckwalter Place, and numerous residential neighborhoods.
